# B. Terms and Conditions - Seminaries Endowment Fund

**Effective Date** 20th August 2024

Your donation to the Seminaries Endowment Fund operated by Seminaries Endowment Fund is subject to the following Terms and Conditions ("Terms"). By making a donation, you agree to these Terms.

"Seminaries Endowment Fund" (the "Fund") refers to the donation platform hosted at [www.sef.or.ke](http://www.sef.or.ke) and any associated services provided by Seminaries Endowment Fund. "Donor Data" means any information provided by donors in the process of making a donation.

## 1. Acceptance of Terms

By contributing to the Seminaries Endowment Fund ("the Fund") or accessing information about the Fund, you agree to be bound by these Terms and Conditions. If you do not agree with these terms, please refrain from participating in or donating to the Fund.

## 2. Purpose of the Endowment Fund

The Seminaries Endowment Fund was set up under the Kenya Conference of Catholic Bishops (KCCB) to ensure that the five major seminaries in Kenya have the resources to effectively and comfortably carry out the role of training future priests for the Church in Kenya.

## 3. Donations and Contributions

To donate to the Seminaries Endowment Fund, you must (i) provide accurate payment information, (ii) ensure that you are authorized to use the payment method you choose, and (iii) be at least 18 years of age.

You may choose to donate through the payment options provided by our partner, iPay including but not limited to card payments and bank transfers, or through Mpesa and/or cheques.

The donations made are:

- **Voluntary Contributions:** Donations to the Fund are entirely voluntary. By making a donation, you acknowledge that your contribution is a gift without expectation of any goods or services in return.

- **Non-Refundable:**All donations to the Fund are non-refundable. Once a donation is made, it cannot be returned, except under exceptional circumstances at the sole discretion of the National Coordinator of the Seminaries Endowment Fund.

## 4. Use of Funds

The donations will be invested and managed according to the Fund's investment policy. The income generated from the Fund will be used to support the Fund's objectives as outlined above. The principal amount of the endowment will be preserved to ensure long-term sustainability.

## 5. Use of Donor Data

We respect the privacy of our donors and will not sell, trade, or share Donor Data with third parties, except as required by law or as necessary to process your donation.
