Your donation to the Seminaries Endowment Fund ("SEF") operated by Seminaries Endowment Fund is subject to the following Terms and Conditions ("Terms"). By making a donation, you agree to these Terms.

"Seminaries Endowment Fund" (the "Fund") refers to the donation platform hosted at sef.or.ke and any associated services provided by Seminaries Endowment Fund. "Donor Data" means any information provided by donors in the process of making a donation.

We reserve the right to update and modify these Terms at any time without prior notice. Your continued use of the Fund after any modifications to the Terms constitutes acceptance of those changes.

1. Making a Donation

To donate to the Seminaries Endowment Fund, you must (i) provide accurate payment information, (ii) ensure that you are authorized to use the payment method you choose, and (iii) be at least 18 years of age. Donations made by automated methods are not permitted.

You may choose to donate using payment options provided by our payment partner, iPay, including but not limited to Mpesa, card payments, and bank transfers.

All donations are final and non-refundable.

2. Use of Donor Data

We respect the privacy of our donors and will not sell, trade, or share Donor Data with third parties, except as required by law or as necessary to process your donation.

By making a donation, you consent to the collection, processing, and use of your Donor Data for the purposes of processing your donation and providing you with updates on the Fund's activities, unless you opt out of such communications.

3. Security

We take the security of your donation information seriously and employ industry-standard security measures to protect it.

However, we cannot guarantee the security of information transmitted over the internet or stored electronically. You acknowledge and agree that you provide your donation information at your own risk.

4. Limitation of Liability

Seminaries Endowment Fund and its affiliates, officers, directors, employees, agents, and partners shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in any way connected with your use of or inability to use the Fund, including but not limited to damages for loss of profits, goodwill, use, data, or other intangible losses.
